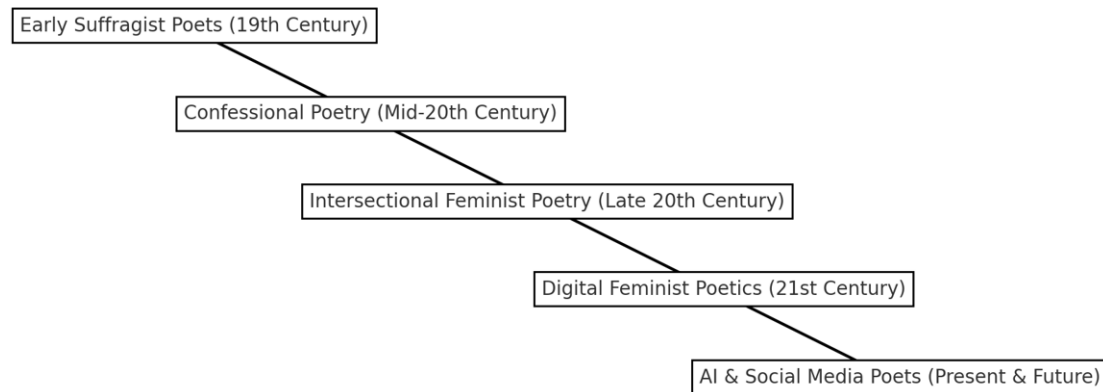

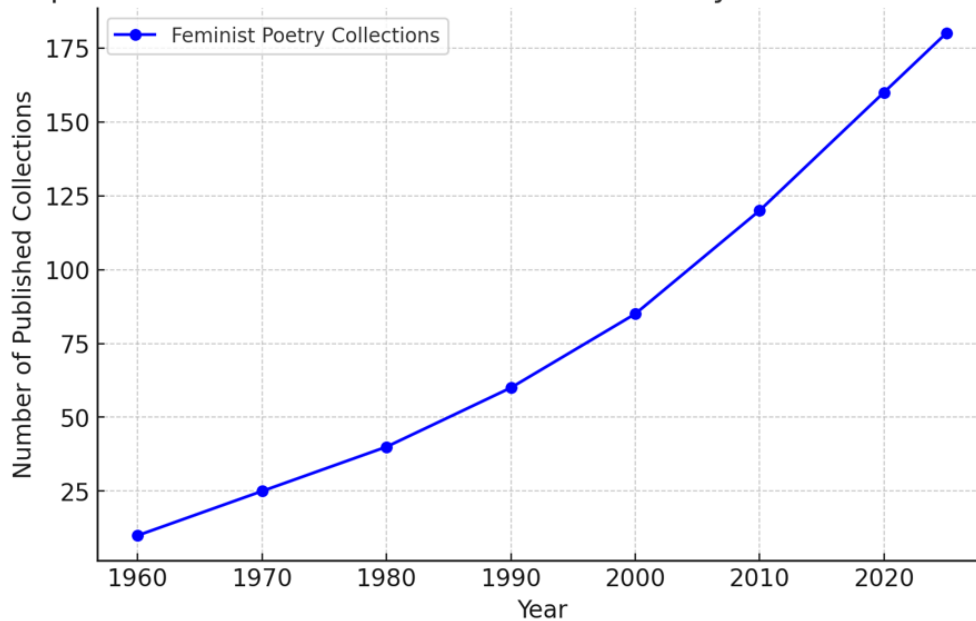
*For those of us who were imprinted with fear like a faint line in the center of our
